# BYLAW 21-020 OF LAC LA BICHE COUNTY

# A BYLAW OF LAC LA BICHE COUNTY TO ESTABLISH THE AGRICULTURAL APPEAL COMMITTEE AND THE SOIL CONSERVATION APPEAL COMMITTEE

**WHEREAS**, section 15 of the *Agricultural Pests Act*, RSA 2000 c. A-8, requires the establishment of a committee to hear appeals respecting notices issued under the Act;

**AND WHEREAS**, section 14 of the *Soil Conservation Act*, RSA 2000 c. S-15 requires the establishment of a committee to hear appeals respecting notices issued under the Act;

**AND WHEREAS**, section 19 of the *Weed Control Act*, RSA 2008 c. W-5.1 requires the establishment of an independent panel to determine appeals of an inspector's notices, a local authority's notices, or debt recovery notices issued under the Act;

**AND WHEREAS**, the Council of Lac La Biche County considers it expedient to establish an Agricultural Appeal Committee to hear appeals under the *Agricultural Pests Act* and the *Weed Control Act*, and to establish a Soil Conservation Appeal Committee to hear appeals under the *Soil Conservation Act*.

**NOW THEREFORE** the Council of Lac La Biche County, duly assembled, enacts as follows:

#### Title

**1** This bylaw is called the "Agricultural Appeal Committee and Soil Conservation Appeal Committee Bylaw".

# **Definitions**

- 2 In this bylaw, the following words and phrases shall have the following meanings:
  - (a) "Agricultural Pests Act means the Agricultural Pests Act, RSA 2000, Chapter A-8.
  - (b) "Chief Administrative Officer" means the person appointed by Council as the Chief Administrative Officer pursuant to the *Municipal Government Act, RSA 2000, Chapter M-26*;
  - (c)
  - (d) Committee" means the Agricultural Appeal Committee and the Soil Conservation Appeal; Committee
  - (e) "Council" means the Council of Lac La Biche County;
  - (f) "Councillor" means an elected official of Lac La Biche County and includes the Mayor;

- (g) "Member" means a Member of a Board appointed by Council;
- (h) Member at Large means a Member of the Committee/Board appointed by Council and who is not a Councillor:
- (i) "Presiding Officer" means the person who presides over a hearing in accordance with this Bylaw.
- (j) "Soil Conservation Act" means the Soil Conservation Act, RSA 2000, Chapter s-15; and
- (k) "Weed Control Act" means the Weed Control Act, RSA 2008, Chapter W—5.1.

# **Agricultural Appeal Committee Establishment and Membership**

- **3(1)** The Agricultural Appeal Committee of Lac La Biche County is hereby established.
- (2) The function and duties of the Agricultural Appeal Committee are to hear and decide on appeals received by Lac La Biche County pursuant to the *Agricultural Pests Act* and the *Weed Control Act*.
- (3) The Committee shall consist of three members at large or three Council members independent of the Agricultural Service Board or a combination of members at large and Council members not on the Agricultural Service Board. Committee members shall be appointed by Council.

# Soil Conservation Act Appeal Board Establishment and Membership

- **4(1)** The Soil Conservation Act Appeal Committee of Lac La Biche County is hereby established.
- (2) The function and duties of the Soil Conservation Appeal Committee are to hear and decide on appeals received by Lac La Biche County pursuant to the *Soil Conservation Act*.
- (3) The Soil Conservation Appeal Committee shall consist of members of the Agricultural Service Board

# **Term of Office**

- **5(1)** Council will, by resolution at the annual Organizational Meeting of Council, appoint members to the Agricultural Appeal Board and Soil Conservation Act Appeal Board for a term of one year, to begin at the start of the calendar year.
- (2) A Councillor who ceases to be a Councillor automatically ceases to be a Member.
- (3) A Member at Large who ceases to be an Agricultural Service Board Member automatically ceases to be a Member.

- (4) If at any time, a vacancy occurs on the Committee, Council may appoint a person to fill that vacancy for the remainder of the term, effective the date of appointment or some other date as determined by Council.
- (5) Council may remove a Member from the Board at any time for any reason at Council's sole discretion.
- **(6)** A Member may resign from the Board by giving written notice to the Chair and the Chief Administrative Officer.

# **Hearing Procedures and Presiding Officer**

- **6(1)** The Committee may establish administrative and hearing procedures, which in the opinion of the Committee, support the fulfillment of their duties, and that are in accordance with the applicable legislation and this Bylaw.
- (2) All Members shall bring administrative or procedural concerns to the attention of the Presiding Officer.
- (3) The Presiding Officer shall be a Councillor appointed to the Board. If a Councillor is not able or eligible to participate in the hearing, the Presiding Officer shall be appointed at the commencement of the hearing from among the participating Members.
- (4) On receipt of a notice of appeal related to the Agricultural Pests Act of the Weed Control Act, the Agricultural Appeal Committee will be convened to hear the appeal.
- (5) On receipt of a notice of appeal related to the Soil Conservation Act, the Soil Conservation Appeal Committee will be convened to the hear the appeal.
- (6) Quorum shall be a majority of Committee members.
- (7) In the event quorum is not met for a hearing, the Committee may open the hearing for the purpose of deciding to adjourn the hearing to a different date and time.
- (8) All Committee hearings are open to the public, but the Committee may deliberate and make its decisions in private.
- (9) Proceedings shall be in accordance with this Bylaw and Lac La Biche County's Meeting Procedures Bylaw.

#### Clerk

- **7(1)** The position of Clerk is hereby established, and the Chief Administrative Officer is authorized to appoint one or more employees to the position of Clerk.
- (2) The Clerk shall fulfill the duties and responsibilities prescribed in the Agricultural Pests Act, Weed Control Act, Soil Conservation Act, Lac La Biche County Bylaws and Policies, and any hearing procedures established by the Presiding Officer, which shall include but is not limited to:
  - (a) receive notices of appeal;

- (b) schedule a hearing and provide notice of the hearing;
- (c) keep an accurate record of the proceedings of the Board, and
- (d) communicate decisions to the affected parties.

#### **Decisions**

- **8(1)** The Committee shall issue a written decision with reasons in accordance with the Act. A decision of the majority shall be the decision of the Board.
- (2) The decision of the Committee shall be signed by the Presiding Officer of the panel and if the Presiding Officer cannot sign, the decision shall be signed by a member of the Board that heard the appeal.

# Fees

**9** A notice of appeal must be accompanied by the appeal fee in order to be considered complete. The fees for filing an appeal are those prescribed in the Lac La Biche County Schedule of Fees and Charges Bylaw, as amended from time to time and as prescribed in the *Agricultural Pests Act*.

#### Remuneration

- **10(1)** The remuneration, traveling, and other expenses of the Members shall be in accordance with the applicable Lac La Biche County remuneration policies, as amended from time to time.
- (2) Remuneration, traveling and other expenses of the Clerk shall be in accordance with Lac La Biche County policies, as amended from time to time.

# Severability

11 All sections of this bylaw are separate and severable. Should any part, section, or subsection of this bylaw be deemed invalid or inoperative by any court or administrative body for any reason, the remaining parts, sections, and subsections shall remain valid and in full force and effect.

#### **Effective Date**

12 This bylaw shall come into force and effect upon third reading.
