

**BYLAW 22-006
OF
LAC LA BICHE COUNTY**

A BYLAW OF LAC LA BICHE COUNTY IN THE PROVINCE OF ALBERTA FOR THE CANCELLATION OF PLAN OF SUBDIVISION.

WHEREAS section 658 of the *Municipal Government Act*, R.S.A. 2000, Chapter M-26 and amendments thereto, enable a Council, by bylaw, to order a subdivision plan cancelled, in whole or in part;

AND WHEREAS consent to cancel a plan of subdivision, certificate of title 212 188 409 (Lot 6, Block 1, Plan 1820858), to accommodate the consolidation of land with certificate of title 222 003 141 (Lot 2, Plan 0023713), has been given by the owners, and all persons shown on the certificate of title of the land in the plan of subdivision as having an estate or interest in it;

AND WHEREAS the owners of the certificate of title 212 188 409 (Lot 6, Block 1, Plan 1820858) and certificate of title 222 003 141 (Lot 2, Plan 0023713) have requested that the County cancel the plan of subdivision;

NOW THEREFORE under the authority and subject to the provisions of the *Municipal Government Act*, and by virtue of all other powers enabling it, the Council of Lac La Biche County, duly assembled, enacts as follows:

Cancellation of Plan of Subdivision

- 1 That the lands described in certificate of title 212 188 409 (Lot 6, Block 1, Plan 1820858) as shown on Schedule "A" in the amount of 0.809 hectares (2.0 acres), more or less, be cancelled from the plan of subdivision record.
- 2 That the cancelled subdivision plan be consolidated with certificate of title 222 003 141 (Lot 2, Plan 0023713).

Effective Date

- 3 This Bylaw shall come into effect upon passing of the third reading.

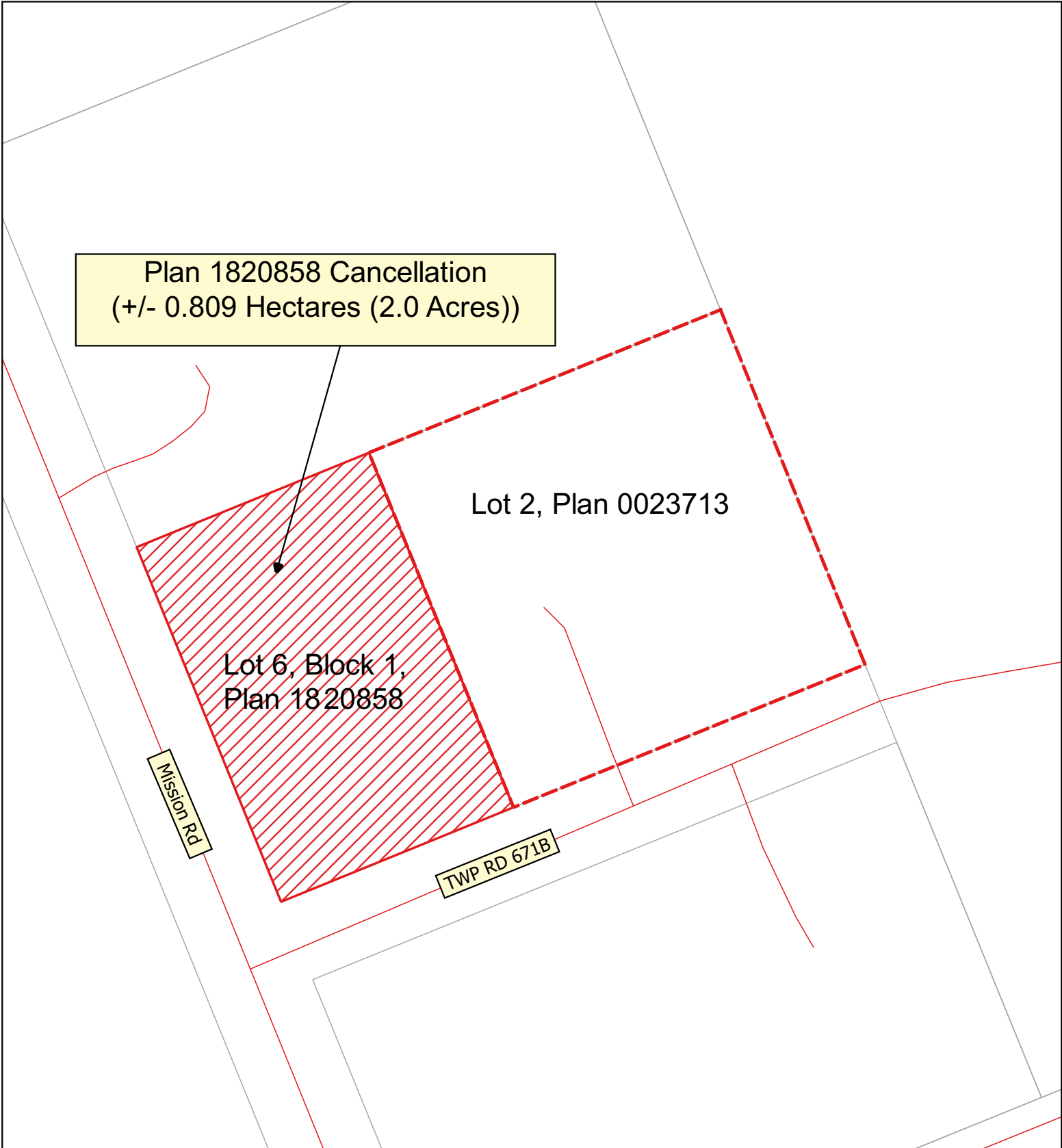
