

**BYLAW 20-021
OF
LAC LA BICHE COUNTY**

A BYLAW OF LAC LA BICHE COUNTY IN THE PROVINCE OF ALBERTA TO AMEND MINISTERIAL ORDER #551/90, AS AMENDED, BEING THE LAC LA BICHE LAKE MANAGEMENT PLAN AREA STRUCTURE PLAN OF LAC LA BICHE COUNTY.

WHEREAS the Minister of Municipal Affairs, as Council for Improvement District #18(South), adopted Ministerial Order #551/90 to be used as the Lac La Biche Lake Management Plan Area Structure Plan; and

WHEREAS it is deemed expedient to amend Ministerial Order #551/90, as amended, as set out in Section 692 of the *Municipal Government Act*, R.S.A. 2000, Chapter M 26, as amended;

NOW THEREFORE under the authority and subject to the provisions of the *Municipal Government Act*, and by virtue of all other powers enabling it, the Council of Lac La Biche County, duly assembled, enacts as follows:

Ministerial Order #551/90 Amendments

1 That Ministerial Order #551/90, as amended, being the Lac La Biche Lake Management Plan Area Structure Plan is amended as follows:

- (a) Map 1 is amended such that part of RL-35-67-14-W4M (Lot 35, Plan LACLABI) containing 1.8 Ha (4.5 acres) in size more or less, as shown on Schedule 'A' of this Bylaw, is redesignated from Rural Conservation Area to Residential Area, and
- (b) Land Use Policy 2.3, Residential Area, is amended with the addition of clause 2.3(d) that reads:

“Subdivision of lands in the identified residential areas may be permitted. Subdivision applications must comply with the existing Municipal Development Plan and regulations set forth in the current Land Use Bylaw and any other relevant planning documents.”

Severability

2 Each provision of this Bylaw is independent of all other provisions. If any such provision is declared invalid by a court of competent jurisdiction, all other provisions of this Bylaw will remain valid and enforceable.

Effective Date

3 This bylaw shall come into effect upon passing of the third reading.

THAT BYLAW 20-021 BE GIVEN FIRST READING THIS 2nd DAY OF JUNE, 2020.

THAT BYLAW 20-021 BE GIVEN SECOND READING THIS 23rd DAY OF JUNE, 2020.

THAT BYLAW 20-021 BE GIVEN THIRD AND FINAL READING THIS 23rd DAY OF JUNE, 2020.

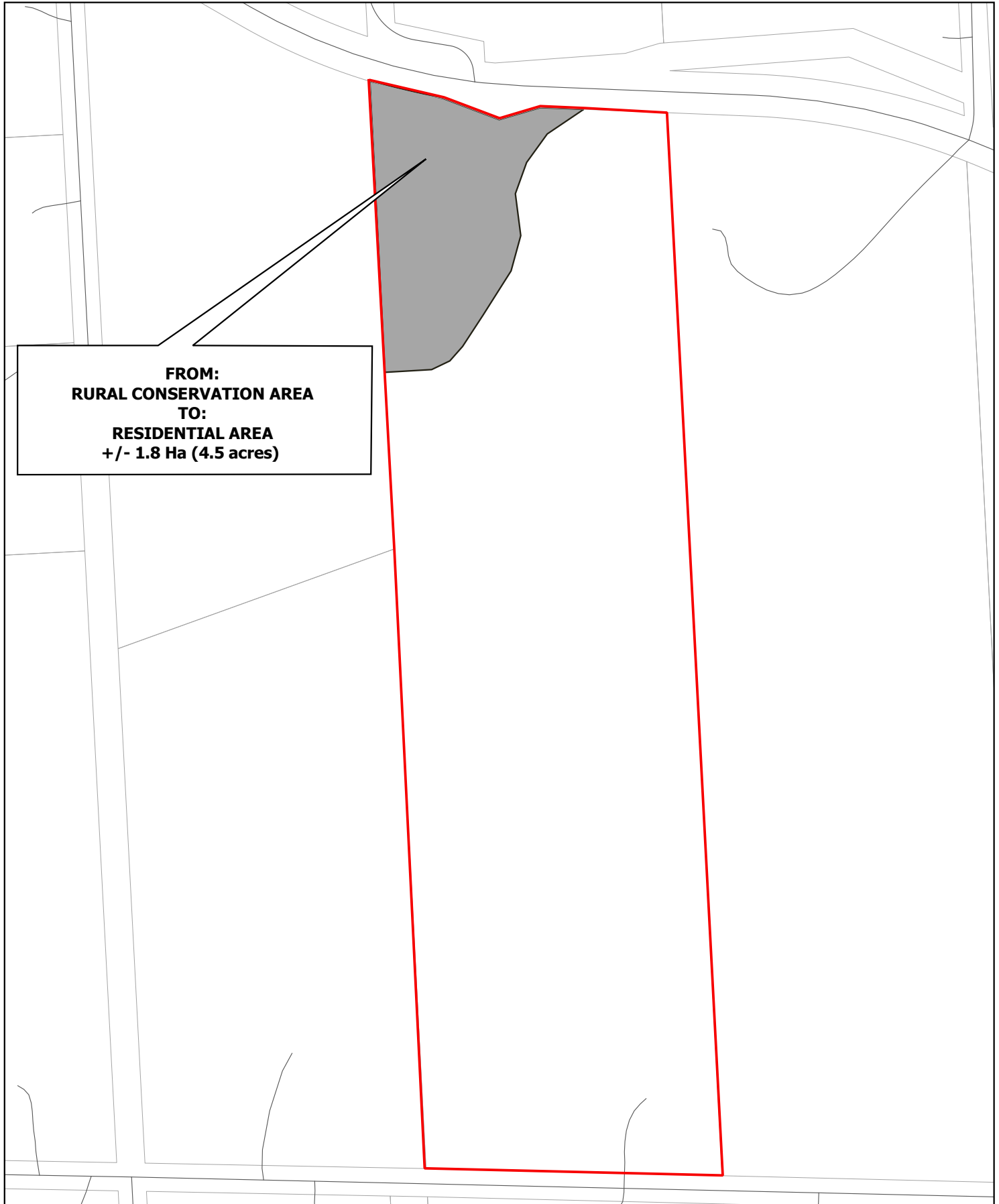
