BYLAW 17-006 OF LAC LA BICHE COUNTY

A BYLAW OF LAC LA BICHE COUNTY IN THE PROVINCE OF ALBERTA TO ADOPT THE SOUTH LAC LA BICHE MAJOR AREA STRUCTURE PLAN AND AMEND BYLAW 1184/01 BEING THE HIGHWAY 36 AREA STRUCTURE PLAN.

WHEREAS in accordance with the Municipal Government Act, S.A. 2000, Chapter 26, as amended, allows a municipality to adopt an Area Structure Plan; and

WHEREAS the Council has adopted Bylaw 1184/01 being the Highway No. 36 Area Structure Plan; and,

WHEREAS under the authority and pursuant to the Municipal Government Act, Chapter M 26.1, R.S.A. 2000, and amendments thereto, Council may amend the provisions of an Area Structure Plan; and,

WHEREAS the Council of Lac La Biche County deems it proper to amend Bylaw 1184/01 as set out in Section 692 of the Municipal Government Act, R.S.A., Chapter M 26, as amended; and,

NOW THEREFORE under the authority and subject to the provisions of the Municipal Government Act, and by virtue of all other powers enabling it, the Council of Lac La Biche County, duly assembled, enacts as follows:

- 1. The South Lac La Biche Major Area Structure Plan attached hereto as Schedule "A", is hereby adopted.
- 2. The Area Structure Plan Boundary identified on Figures 1-10 of Bylaw 1184/01 being the Highway 36 Area Structure Plan are amended to exclude those areas that fall within the Area Structure Plan boundaries of the South Lac La Biche Major Area Structure Plan depicted within Schedule "B" attached to and forming a part of this Bylaw.
- 3. Sections 2.2, 2.4, 2.8, 2.9, 2.11, 4.1, 4.3, 4.4, 4.5 and 6.1 within Bylaw 1184/01 are amended as shown within Schedule "B" attached to and forming a part of this Bylaw.
- 4. Appendix A Development Statistics Table within Bylaw No. 1184/01 is amended as shown within Schedule "B" attached to and forming a part of this Bylaw.
- 5. This Bylaw shall come into effect upon passing of the Third Reading.
