A BYLAW OF LAC LA BICHE COUNTY IN THE PROVINCE OF ALBERTA FOR THE PURPOSE OF MAKING AMENDMENTS TO THE PLANNING AND DEVELOPMENT SCHEDULE OF FEES AND FINES BYLAW 21-026

---

**WHEREAS** pursuant to the Municipal Government Act (“the Act”), R.S.A 2000, Chapter M-26, as amended, County Council may pass bylaws for municipal purposes respecting services provided on behalf of the municipality; and

**WHEREAS** the Act provides for a municipality to pass bylaws respecting the enforcement of bylaws, including the creation of offences and imposition of fines; and

**WHEREAS** the Act provides for a municipality to pass bylaws to establish fees for license, permits and approvals on behalf of the municipality; and

**WHEREAS** pursuant to the Safety Codes Act, R.S.A. 2000, Chapter S-1, County Council may pass a bylaw as an accredited municipality respecting adopting permit fees for building, electrical, plumbing and gas disciplines; and

**WHEREAS** Lac La Biche County deems it expedient to set fees and fines related to planning and development services and safety codes permits within the Municipality;

**NOW THEREFORE** under the authority and subject to the provisions of the Municipal Government Act, and by virtue of all other powers enabling it, the Council of Lac La Biche County, duly assembled, enacts as follows:

**Bylaw 21-026 Amendments**

- 1 That Bylaw 21-026, being the Planning and Development Schedule of Fees and Fines Bylaw is amended as follows:
  - a. That Schedule A, Section B-Safety Codes Fees of the Planning and Development Schedule of Fees and Fines Bylaw shall be amended to include:
    - (i) “A permit extension fee for any discipline costing \$150.00 can be applied for which would allow that specific issued permit to be valid for one (1) year”.
    - (ii) “A variance fee for any discipline costing \$125.00/hour with a two (2) hour minimum can be applied for to vary a permit if the requested variance is equal or more than that discipline code requirement.”

**Severability**

- 2 Each provision of this bylaw is independent of all other provisions. If any such provision is declared invalid by a court of competent jurisdiction, all other provisions of this bylaw will remain valid and enforceable.

**Effective Date**

- 3 This bylaw shall come into effect upon passing of the third reading.
