





# **Notice of Construction**

Lac La Biche County will be replacing the water main and the water/sewer services along Highway 858 from Plamondon Avenue to 102 Avenue. Construction will also take place along 101 Avenue from Highway 858 to 102 Street. The work is scheduled to be completed over the 2018 and 2019 construction seasons.

The 2018 construction schedule is anticipated to start on April 23, 2018 and work through to September 30, 2018. This work area will include Highway 858 from Plamondon Avenue to 100 Avenue and the back alley to the east of Highway 858. Note that equipment mobilization and site preparation including brushing will take place within the back alley as soon as possible.

A detailed 2019 construction schedule will be provided prior to work starting in 2019. However, the construction season is anticipated to occur between the months of April and September of 2019.

# **Scope of Work**

Work will be completed in phases starting at the south end of Plamondon.

A temporary water line will be installed to ensure water service is maintained to all residents. Some residents outside the construction zone may be on the temporary water line as well due to proximity to the isolation valve and replacement.

**Phase 1:** Installation of water main along Township Road 680 (back alley east of Highway 858) from 100 Avenue to Plamondon Avenue.

**Phase 2:** Replacement of water main along Highway 858 from 96A Avenue to 98 Avenue. Highway 858 will remain open to single lane alternating traffic.

**Phase 3:** Replacement of water main and services along Highway 858 from 98 Avenue to 100 Avenue. Highway 858 will remain open to single alternating traffic.

**Phase 4:** Replacement of water main and services along Highway 858 between 100 Avenue and 102 Avenue. The bridge at 102 Avenue will remain open, and traffic will be detoured to 101 Street.

**Phase 5:** Replacement of the water main, re-lining sewer main and replacing services on 101 Avenue from Highway 858 to 102 Street. 101 Avenue will be fully closed with detours during construction.

# **Property Access and Detours**

During 2018 construction, Highway 858 will always maintain at least one lane of flowing traffic. There may be single lane and full road closures on side avenues.

Road closures and work areas will be staged to minimize the impact on the community. Every effort will be made to maintain access to driveways and businesses in construction zones during construction. Construction activities and movement of equipment may impact access to private property. Additional notices will be handed out to those most affected by road closures prior to them being put into effect.







# **Water Service and Water Interruptions**

Temporary water service connections will be installed to residences and businesses affected by the replacement of the water main. Temporary water service connections will be completed via a hook up to your outside water tap connection. We will need to gain access to your internal water meter to complete the hook up. That will be coordinated with you by our crews on site. There is the potential for short term (8 hours or less) water shut offs during construction. Additional notices will be handed out to affected residents/businesses 24 hours before any water interruption.

#### **Waste Collection Services**

During construction, some lots will not be accessible to waste and recycling collection services. During this time, residents are asked to leave their bins in their usual locations. Crews will move them to an accessible point and return them following collection.


